Pursuant to Article 33 and 70 of the Law on Public Procurement ("Official Gazette of Bosnia and Herzegovina" No. 39/14) and Article 14 of the Rulebook on the Public Procurement of the City Administration of the City of Banja Luka ("Official Gazette of the City of Banja Luka" No. 34/19, 23/21 and 42/21), and in accordance with the provisions of the Guidelines on the Organization and Conduct of Competitions in the Field of Architecture and Urban Planning ("Official Gazette of the City of Banja Luka "No. 6/18) and the proposal of the Competition Jury for the development of the concept design of the central city memorial to the fallen and missing soldiers in the defense patriotic war of the Republika Srpska dated 17 May 2022, the Mayor of the City of Banja Luka, made on 18 May 2022, the following

DECISION

- I The proposal of the Competition Jury for the Public Procurement No. 03-404-221/21 "Competition for the development of the concept design of the central city memorial to the fallen and missing soldiers in the defense patriotic war of the Republika Srpska on the following awards is accepted as follows:
 - 1. FIRST PRIZE in the amount of EUR 20,000.00 (the equivalent in BAM) is awarded for the competition proposal under the author's code "PC27058" *Author*: "Routing" d.o.o. Banja Luka, *Design Team*: Nikola Dmitrović, Arch.;
 - 2. SECOND PRIZE in the amount of EUR 10,000.00 EUR (the equivalent in BAM) is not awarded.
 - 3. THIRD PRIZE, in the amount of EUR 5.000,00 (the equivalent in BAM) is awarded for the competition proposal under the author's code "15039RT", *Design Team* Marco Tanzilli, Arch. and Claudia Ricciardi, Arch., both from Italy.
- II The Finance Department of the Banja Luka City Administration is responsible for the implementation of this Decision.
- III A written complaint may be lodged with the Mayor against this Decision within five days from the date when the notification is received. The complaint is to be submitted through Department of Spatial Planning of the Banja Luka City Administration.

Statement of Reasons

The Competition Jury for the Development of the central city memorial to the fallen and missing soldiers in the defense patriotic war of the Republika Srpska appointed by the Decision of the Mayor no.12-G-3492/21 of 17 November 2021, in accordance with the Instructions on the Organization and Conduct of Competitions in the Field of Architecture and Urban Planning ("Official Gazette" of the City of Banja Luka, No. 6/18) and the requirements of the Call, conducted the procedure for the selection of the best concept design of central city memorial to the fallen and missing soldiers in the defense patriotic war of the Republika Srpska.

On 9 January 2022, the Public Procurement Notice was published on the website of the Public Procurement Agency of Bosnia and Herzegovina, in the daily newspaper "Euroblic" and "Nezavisne novine", on the official website of the City of Banja Luka and in the "Official Gazette of Bosnia and Herzegovina" number 2/22 of 14 January 2022.

Due to a large number of inquiries by the authors to extend the deadline, who in addition to the complexity of the competition entry and its exceptional importance for the City, as the reasons for the deadline extension, stated also the need to reflect on the artistic idea in the context of the immediate environment and historical theme, the Mayor made a Decision No. 11-G-835/22 dated 9 March 2022 to extend the deadline for submission of the Competition entries to 29 April 2022 until 11:59 pm (GMT +1) (instead of 11:59 pm on 11 April 2022) (GMT +1).

In compliance with the requirements defined in the Competition Announcement and within the designated deadline, a total of eighteen (18) competition entries arrived within the deadline.

Expert Rapporteurs examined the received entries in the period from 3 May 2022 until 12 May 2022. On 13 May 2022, the Report was submitted in writing to the Competition Jury and each proposal was individually verbally explained (Attachment: Report on the submitted entries to the International General Public Competition for the development of the concept design of central city memorial to the fallen and missing soldiers in the defense patriotic war of the Republika Srpska – May 2022).

The Competition Jury reviewed all 18 competition entries and analyzed them individually against the established criteria and requirements defined by the Competition Announcement and the Program of the competition, and decided as follows:

- 1. Competition proposals under the following author's code are eligible for participation: 01 ("CP22849"), 03 ("MI20162"), 04 ("O80808C"), 05 ("15039RT"), 06 ("PC27058"), 10 ("MM77177"), 12 ("15307GA"), 13 ("50855ΕΠ"), 14 ("33177ΜИ") and 15 ("ΚΜ01389");
- 2. There are no attachments in the received competition entries that should be excluded from the evaluation process;
- 3. Due to the failure to meet obligatory requirements of the Competition Announcement, competition entries under the following working numbers ARE NOT ELIGIBLE for further evaluation:



- 02 ("43264MJ") The entry does not contain all the attachments as defined by the Competition Announcement and the offered concept design is not in accordance with the requirements from the Competition Announcement (features and symbols);
- 07 ("RT33218") The entry does not contain all the attachments as defined by the Competition Announcement, and a number of attachments have not been finalized, so it is evident that the proposal has not been completed;
- 08 ("56145MI") The entry does not contain all the attachments as defined by the Competition Announcement, and a number of attachments have not been finalized, so it is evident that the proposal is not been completed;
- 09 ("6377RG2") The entry does not contain all the attachments as defined by the Competition Announcement, and a number of attachments have not been finalized, so it is evident that the proposal has not been completed;
- 11 (,,15101PV") The entry does not contain all the attachments as defined by the Competition Announcement, and a number of attachments have not been finalized, so it is evident that the proposal has not been completed;
- 16 ("87807KH") The entry does not contain all the attachments as defined by the Competition Announcement, and a number of attachments have not been finalized, so it is evident that the proposal has not been completed;
- 17 (,,10484AA") The entry does not contain all the attachments as defined by the Competition Announcement, and a number of attachments have not been finalized, so it is evident that the proposal has not been completed; and
- 18 (,,28463JT") The entry does not contain all the attachments as defined by the Competition Announcement, and a number of attachments have not been finalized, so it is evident that the proposal has not been completed;

The Competition Jury examined and evaluated each individual proposal according to the defined criteria, by comparative evaluation of the quality of the submitted designs classified according to the common characteristics of the concepts. The Competition Jury selected the proposals in three rounds and evaluated and scored the competition proposals from the shortlist, and ranked them according to the quality of the offered designs respecting the purpose of the competition, the objective of the competition task and the evaluation criteria. Pursuant to the provisions of Articles 41 and 67 of the Guidelines on the organization and conduct of the competitions in the area of architecture and spatial planning ("Official Gazette of the City of Banja Luka, number 6/18) and Item 6 of the Competition Announcement, the Competition Jury has decided to award one first prize in the amount of EUR 20,000.00 (equivalent in BAM) and one third prize in the amount of EUR 5,000.00 (equivalent in BAM). With regard to quality and value, the Jury decided not to award the second prize on the grounds that none of the offered proposals was closely behind the separately selected first prize awarded concept design. The proposal that was singled out for the third prize provided certain quality solutions, but not to the extent that it could be selected for the second prize.

Based on the above stated, at its session held on 17 May 2022, the Competition Jury decided and submitted to the Contracting Authority the Minutes on the evaluation of the submitted proposals and the Final Report on the work of the Competition Jury with the list of the

proposed awards for the International General Public Competition for the development of the concept design of the central city memorial to the fallen and missing soldiers in the defense patriotic war of the Republika Srpska Luka

The proposal of the Competition Jury was accepted; hence it was decided as in the dispositive.
